### **1. Introduction**

- 1.1 This Project is on the Laws of Samoa, as of December 2016. It was initiated by the Samoa Law Reform Commission (Commission) initially to enable the Commission to respond more effectively to its statutory mandate, that of the review and the reform of the laws of Samoa. Other obvious benefits to the country (in the respectful view of the Commission) are listed below.
- 1.2 Under its statutory responsibilities, the Commission is also required:<sup>1</sup>

"to research and analyse areas of law considered to be in need of reform and report its recommendations for reform to the Prime Minister and the Attorney General."

- 1.3 The Commission operates only on the Terms of References from three (3) sources, the Honourable Prime Minister, Cabinet and the Attorney General. The Commission may initiate Terms of Reference for review or reform of the law after endorsement by the Honourable Prime Minister or the Attorney General. This Project is on such Terms of Reference. It is acknowledged that an overall background knowledge of the fabric of laws of Samoa is necessary for effective law making.
- 1.4 This effort is the first of its kind and it is hoped that it will be carried out periodically, to enable Samoa to continue to operate on current and updated laws. Other benefits of this Project include the following.

### **Benefits**

- a) Public:
  - The public is better informed of laws. Government will be in a position to better inform the public on the current and existing laws in Samoa in a simplified, more comprehensible and accessible manner.

### b) Parliament:

- i) The Constitutional function of law making (amendment laws or new laws) is further informed by an appreciation of the fabric of laws of Samoa.
- ii) For every new or amendment law, there would be some idea of where this new law would be placed or fit into the fabric of laws.

- iii) There would be an earlier appreciation of which Ministry, State Owned Enterprise or Constitutional Office (Ministry/SOEs/COs) the new or amendment laws would impact upon in implementation.
- iv) Under their 'oversight of government' functions, Parliament may require Ministry/SOEs/COs, in their Annual Reports to explain or clarify how the set of laws they are responsible for have been administered in a given financial year; inclusive of reasons and/or qualifications.
- **c) Executive:** The Constitutional duty of policy making for the country will be informed by an appreciation of the fabric of laws.
  - Cabinet, the Public Service Commission and the Ministry of Public Enterprise are able to regulate the Ministries/SOEs/COs according to a now identified set of laws each Ministry/SOEs/COs is established under and/or administers.
  - The set of laws administered by a Ministry/SOE/CO may impact on the budget the Ministries/SOEs/COs seeks in a financial year.
  - iii) Ministries/SOEs/COs are now in a position to propose law reform projects beneficial for and to build on their mandates further.

#### d) Judiciary:

- i) The Constitutional duty of **applying the law** is informed by the fabric of laws of Samoa.
- ii) The Judiciary would be in a better position to propose reforms to the relevant laws if they find that in the application of the law, the current laws have loopholes which need to be addressed.
- 1.5 Overall, an appreciation of the overall fabric of laws and which laws are administered by which Ministry/SOEs/COs is helpful for a whole of Government sector approach to policy development and decision making.

### 2. PART A: The Terms of Reference

### a) The Terms of Reference

2.1 On 4 August 2017, the Hon Prime Minister accepted and endorsed the Terms of Reference on a Project entitled 'The Review of the Laws of Samoa' initiated by the Commission. The Commission refers to this Project as 'Toe Timata le Upega - O Tulafono a Samoa'.

- 2.2 The **Terms of Reference** are as follows:
  - i) To identify the current fabric of laws (all 285 existing Acts of Parliament) of Samoa;
  - ii) To identify which Ministries, State Owned Enterprises (SOEs), or Constitutional Offices (COs) are responsible for which laws (legal authority); and
  - iii) To identify and confirm from Ministries/SOEs/COs any outdated laws under their administration and recommend removal, updating or replacing.
- 2.3 Given (i) and (ii) above, TOR 3 was treated in this particular context, in that only Ministries who responded 'No' or 'Uncertain' to their list of laws, when consulted on these responses, were also queried on their views on what and how these laws and their other laws were to be addressed, i.e. whether they would recommend repeal or updates. In the interests of limiting the scope of this Review to a realistic project at this point in time, not all Ministries, SOEs and COs were therefore consulted to address TOR 3. This is perhaps a question to be asked of all Ministries and Offices at the next Review of the Fabric of Laws of Samoa. The Commission's consultation experience from this Review, i.e. consulting on this question, is helpful to inform that future Review.

### b) Review Stages

- 2.4 At the outset, the Commission confirmed the steps or phases in which this project will be undertaken:
  - a) To identify and confirm all laws (Acts & Ordinance) existing and current in Samoa to December 2016.
  - b) To identify which (Ministries/SOEs/Constitutional Offices) is responsible for which laws.
  - c) To identify and confirm from Ministries/SOEs/Constitutional Offices any outdated laws and recommend removal, updating or replacing.
- 2.5 It was also indicated that ideally:
  - d) As approved by the Honourable Prime Minister and Cabinet, disseminate the fabric of laws in a given year in simplified means through the use of charts, graphs.
  - e) To keep updating Samoa's laws, and where feasible, to update annually.

# 3. PART B: TOR 1 - The current fabric of laws of Samoa – The 285 laws

### a) Preliminary Research

#### i. The current fabric of Samoa's laws

3.1 TOR 1 requires the identification of all laws (Acts & Ordinances) existing and current in Samoa as of December 2016. This is already available under the very helpful **Consolidation of Laws Project** undertaken by the Office of the Attorney General annually, under the Revision and Publication of Laws Act 2008.<sup>2</sup> The Consolidation of Laws 2016 records that as of December 2016, Samoa was operating on a total of 285 laws of Parliament. These 285 laws are set out alphabetical order in **ANNEXURE 1** to this Report.

### ii. The Constitutional Offices (COs), Ministries, Public Bodies (SOEs) and Statutory Offices of Samoa.

3.2 Having identified the fabric or the existing laws of Samoa to December 2016, to understand which Ministry or Constitutional Office is responsible for which law, and to assist with TOR 2, it was necessary to identify, what the law says on what Constitutional Offices,

**Ministries and SOEs (Public Bodies) and Statutory Offices exist**. The Tables immediately below set out the Constitutional Offices, Ministries, SOEs (Public Bodies) and Statutory Offices existing according to the laws of Samoa. This also gives an overall picture of the existing Government Sector of Samoa.

### 4. PART C: TOR 2 - Laws and responsible authorities

4.1 What does the law <u>currently</u> say? Which Ministries, State Owned Enterprises (SOEs), or Constitutional Offices (COs) are responsible for which laws?

### a) Research - Which Office is administering which laws?

- 4.2 Having identified the 285 laws of Samoa (ANNEXURE 1), and the existing Ministries/SOEs/COs according to the laws of Samoa (above), the Commission set out to find which office (above) is responsible for which laws (ANNEXURE 1). To answer this, the Commission undertook the following.
  - 1. Reviewed each of the 285 laws to identify:

- (i) all provisions that <u>expressly state</u> which Ministry administers the law, for example, 'Subject to the control and direction of the Minister, the Ministry is charged with the administration of this Act...;<sup>3</sup>
- (ii) the responsible Ministry or Minister in the Interpretation section, for example,
   *"Minister"* means the Minister responsible for Women Affairs; "Ministry" means the
   Ministry of Women, Community and Social Development;<sup>4</sup>
- (iii) at the end part is where the administration authority is stated for example, "This Act is administered by the Ministry of Women, Community and Social Development".<sup>5</sup> The Office of the Clerk of the Legislative Assembly is responsible for printing Acts assented by O le Ao o le Malo.<sup>6</sup> It appears that the decision on who administers each Act; which OCLA records at the end of each Act when printed, is based on which Minister signs the Bill when it is tabled in Parliament.
- 2. The Commission also checked the official websites of the government Ministries, SOEs and Constitutional Offices for express statements on which laws they administer. This is supplemented by phone calls to the government offices for confirmation from the officers of that office themselves.
- 3. Also of significant assistance was the Legislative Assembly Updated List, 'Tables of Samoa Acts and Ordinance & Statutory Regulations as at 31 December 2016' compiled by the Office of the Clerk of the Legislative Assembly, also known to government drafters of Samoa as 'the red book'.








### i. Figure 1 - Number of Laws Administered Per Government Office (Pie Chart)

# 5. PART D: TOR 3 - Laws requiring removal, updating or replacing.

5.1 TOR 3 required the Commission to identify and confirm from Ministries/SOEs/COs any outdated laws under their administration and recommend removal, updating or replacing. The comments in page 6 (above) on TOR 3 are repeated here, as those comments define the scope of the Offices consulted.

### (a) The Consultations

5.2 On 21 August 2017, the first step in consultation was to send out letters first seeking from each Constitutional Office, Ministry and SOE's confirmation that they administer the preliminary list of laws in the findings of the Commission. In the consultations proper, some Offices recommended the repeal, updating and/or replacement of some of the laws under their responsibility. These were recorded and are analysed in summary in the consultation outcomes or the Findings below.

5.3 The process under which these consultations were carried out is set out in **ANNEXURE 2**. The findings are set out immediately below.

### (b) The Findings

- 5.4 The requests for review and recommendations below are on the 285 laws upon which the TOR was instructed and upon which respective Constitutional Offices, Ministries, Public Bodies (SOEs) and Statutory Offices (Offices) were consulted. Most Offices confirmed they administered the list of laws given them, and thus were not consulted again, but some responded 'NO' or that they were 'UNCERTAIN' on some of their laws. For a number of laws, more than one office is responsible for implementation. In such cases, for the purposes of this Review, the 'Principal' administrator is noted as the responsible Ministry/office, with the understanding there are other offices responsible for the same law. For example, MCIT and OOTR for the Telecommunications Act 2005.
- 5.5 The following **Table of Consultation Outcomes** sets out the consultation outcomes, on the laws that the Offices sought updating and revising, repealing or replacing. In understanding the Tables, the following applies:
  - i) The Tables are separated according to Offices.
  - ii) **Law** State the law consulted upon.
  - iii) Review Notes the gist of the consultation issues
  - iv) Recommendations on the issue reviewed
  - v) Proposed action to be taken.

## Figure 1 -Proposed Improved Fabric of the Laws of Samoa to Dec 2016 (Pie Chart)




Figure 2 – Proposed Improved Fabric of the Laws of Samoa to Dec 2016 (Chart)





Figure 3 – Proposed Improved Fabric of the Laws of Samoa to Dec 2016 (Columns)



# 7. PART F – Summary of Recommendations

**7.1** The Table below lists the Summary of Recommendations informed by the consultations. The recommendations for future revisions to update laws are indicated in red font.

Summary of Recommendations
Recommendation 1:
It is recommended that if the proposed review shows there is no need for the General Laws
(No.2) Ordinance 1932 to continue to exist, the Ordinance may be repealed.
Recommendation 2:
It is recommended that the Regulations Ordinance 1953 be updated to reflect the current
process of regulation making in Samoa.
Recommendation 3:
An old law to accommodate the past context. It is recommended that the Law Reform Act
1964 be reviewed on whether any of the few provisions left needs to be included in current
law with a view to repealing this Act.
Recommendation 4:
It is recommended that the Plebiscite Act 1990 be updated and revised to include provisions
requiring both the OEC and the OAG to work together in implementing this Act.
Recommendation 5:

the Ordinance, constables implement enforcement duties. The Ministry of Police is in
agreement.
Recommendation 8:
It is recommended that the Industrial and Provident Societies Act 1968 is moved to MCIL
where the registry of societies is regulated. MCIL supports this (letter of 19 Dec 2017)
Recommendation 9:
It is recommended that the Wills Act 1975 should be under the Public Trust Office as it deals
with the disposition of a deceased person's property. The PTO agrees.
Recommendation 10:
It is recommended that the Administration Act 1975 should be under the Public Trust Office
which regulates the estates of deceased persons. The PTO agrees.
Recommendation 11:
It is recommended that the Copyright Act 1998 is administered by MCIL. MCIL confirms the
Registries of Companies and Intellectual Properties Division within their Ministry is
responsible for copyright registration. It is also in the Ministry's service charter.
Recommendation 12:

It is recommended that the Births, Deaths and Marriages Registration Act 2002 is officially administered by the Samoa Bureau of Statistics, as this is expressly stated in the BDMR Act 2002.

## **Recommendation 13:**

It is recommended that the MOF confirms with the NPF the proper administering authority for the Government Superannuation Act 1972, before the proposal by MOF can be finalized, that this Act falls under NPF.

## **Recommendation 14:**

It is recommended that as SLAC is listed as a Public Trading Body under the Public Bodies (Performance and Accountability) Act 2001, it administers its own Act i.e. Life Assurance Corporation Act 1976.

## **Recommendation 15:**

It is recommended that the National Investment Corporation Act 1981is repealed as it is not known if it was ever used, and other laws already regulate the purpose of this Act.

## **Recommendation 16:**

It is recommended that due to the nature of its work, the official administrator of the Financial Institutions Act 1996 is CBS. CBS agrees.

## **Recommendation 17:**

It is recommended that the official administrator of the Decimal Currency Act 1966 is CBS. CBS agrees.

## **Recommendation 18:**

The Asian Development Bank (ADB) Loan Act 1969 is redundant. It is recommended that it be repealed.

## **Recommendation 19:**

It is recommended that the Public Bodies (Performance and Accountability) Act 2001 is administered by MPE, MPE being the implementing Ministry.

## **Recommendation 20:**

It is recommended that the Royal Samoan Hotel Act 1984 is repealed. There are and have been no records with MOF on any dealings under this Act for a very long time now.

## **Recommendation 21:**

It is recommended that the Bad Debts Act 1990 is repealed. There are no records of any dealings under it for a long time now.

## **Recommendation 22:**

It is recommended that the Development Loan Authorisation Act 2005 is repealed. Its purpose has already been achieved. If there are any outstanding matters, the Acts Interpretation Act 2015 provisions on repealed laws may apply.

## **Recommendation 23:**

It is recommended that the Loan Authorisation Act 2006 is repealed. Its purpose has already been achieved. If there are any outstanding matters, the Acts Interpretation Act 2015 provisions on repealed laws may apply.

## **Recommendation 24:**

It is recommended that the South Pacific Games (Taxation Incentives) Act 2007 is repealed. Its purpose has already been achieved. If there are any outstanding matters, the Acts Interpretation Act 2015 provisions on repealed laws may apply.

## **Recommendation 25:**

It is recommended that the Loan Authority Act 2007 is repealed. Though the loan repayments will be completed by 2027, if there are any issues arising, the Acts Interpretation Act 2015 provisions on repealed laws may apply.

## **Recommendation 26:**

It is recommended that the Samoa Broadcasting Corporation (SBC) Repeal Act 2008 is repealed as its purposes has been fulfilled and is no longer relevant.

## **Recommendation 27:**

Given the bulk of the work under the Electricity Act 2010 is carried out by the Office of the Regulator, it is recommended that the OOTR is the appropriate administrator. The OOTR is of the same view.

## **Recommendation 28:**

It is recommended that the Agriculture Store Corporation Repeal Act 2013 is repealed. The necessary documentations to effect these have been completed, and therefore, this Act is no longer relevant.

## **Recommendation 29:**

It is recommended that the Central Bank of Samoa is the appropriate administrator of the Central Bank Act 2015.

## **Recommendation 30:**

It is recommended that the MNRE as the rightful administrator confirm if the Samoan Market Ordinance 1927 is still useful, and to recommend repeal if the answer is in the negative.

## **Recommendation 31:**

It is recommended that the Building Alignment Ordinance 1932 is repealed. Most of its functions have been assumed by other authorities e.g. PUMA.

## **Recommendation 32:**

It is recommended that the National Parks and Reserves Act 1974 be moved to be administered by MNRE, the appropriate Ministry regulating national parks and reserves for Samoa.

## **Recommendation 33**:

It is recommended that MCIL confirms with other relevant Ministries if the Mercantile Law Act 1975 is still being implemented, and if not, if MCIL would entertain recommending its repeal.

## **Recommendation 34**:

It is recommended that a proper review be carried out on the Telecommunications Act 2005 to clarify the roles of MCIT and OOTR under this Act.

## **Recommendation 35:**

As the Office of the Regulator carries out the functions of these set of laws, it is recommended that the Electricity Act 2010; Broadcasting Act 2010; and the Postal Services Act 2010 are all laws administered by the OOTR. MCIT is substantially involved in policy making.

## **Recommendation 36:**

It is recommended that the MOH confirms if they still have any dealings with the Oceania University of Medicine under the Oceania University of Medicine (Samoa) Act 2002, before confirming the appropriate administrator for the OUM (Samoa) Act 2002.

## **Recommendation 37:**

It is recommended that the MPMC review and confirm the repeal or otherwise of the Samoa Act 1921 (NZ) due to its out datedness.

## **Recommendation 38:**

It is recommended that the MPMC reviews and update the Samoan Antiquities Ordinance 1954 for better enforcement of the laws relating to the preservation of Samoa's antiquities. Proposed amendments to be developed and drafting instructions submitted to the Legislative Drafting Division of the OAG (Attorney General).

## **Recommendation 39:**

It is recommended that given the importance of the Samoan Status Act 1963 to the Samoan people, that the MPMC updates this Act and give it proper enforcement.

## **Recommendation 40:**

It is recommended that the Minister for Revenue invokes his power under the SEG International Enterprise Act 2011 and nominate a repeal date for this Act. The Acts Interpretation Act 2015 will save any entitlements or duties still outstanding.

## **Recommendation 41:**

It is recommended that the MPMC liaise with the OCLA to confirm the appropriate administrator for the Head of States Act 1965.

## **Recommendation 42:**

It is recommended that MWTI settles with MCIL which Office is the principal administering Office for the Sea Carriage of Goods Ordinance 1960. Both to confirm if this Ordinance still has any use for Samoa.

## **Recommendation 43:**

It is recommended that the LTA is the rightful administrator of the Road Traffic Ordinance 1960. The LTA regulates the licensing of vehicle drivers, the condition of land transport etc.

## 8. PART G - Final Words

- 8.1 The Commission hopes the Findings from this Project or Review is helpful for the Government and the people of Samoa. In this regard, the Commission repeats the possible benefits of this Project in pages 4 and 5 above.
- 8.2 This project may be updated annually, in collaboration with the annual 'Consolidation of Laws' project of the Office of the Attorney General. Annual updates may indicate trends of policy making, of emphasis and priorities. These may assist inform Government's future development policies, and the Government's efforts to achieve its development plans for Samoa. The project could also be repeated every 3 to 5 years, depending on the Commission's capacity and budget.
- 8.3 An appreciation of the overall fabric of laws and which laws are administered by which Ministry/SOEs/COs is helpful for a whole of Government sector approach to decision making, but also equally important, for the Commission in effective law making.
- 8.4 We hope the reader of this Report will be as informed on the developments, the strengths and limitations of the laws of Samoa, and be encouraged to create opportunities for the development of laws that Samoa.
- 8.5 Any limitations in this Review is that of the Commission's. The lessons learnt from this first review of the Fabric of Samoa's Laws are noted and will be helpful in improving the processes in undertaking the next such review.
- 8.6 We are thankful for the opportunity to undertake this Review, and acknowledge the generous assistance rendered to the Commission by all Government Ministries, Government

Organisations (SOEs), Constitutional Offices and Statutory Authorities during the process of this Review.

8.7 The Commission looks forward to the next <u>Review of the Fabric of Samoa's Laws</u> Project!

## (a) The Process

The process under which these consultations for TOR 3 were carried out are as follows.

To start off, letters were sent to respective government offices attaching Tables of the preliminary findings of the Commission, seeking from each office confirmation of the preliminary list prepared by the Commission, of the laws they administer. The offices were also asked to include any laws which they administer but was missing from the Commission's preliminary findings.

By Friday 1 September 2017, the Commission started receiving responses which were noted. Having received responses back from the Ministries, SOEs and Constitutional Offices; and upon review of those responses, it was decided that for all <u>those Offices which confirmed they</u> <u>administer all the laws in the list given them</u>, there was no need to confirm with them again.

It was also decided that the <u>SOEs and statutory bodies established under their own</u> (individual) laws (e.g. Office of the Electoral Commission) did not need to be consulted.

## b) Ministries SOEs and COs not consulted and reasons

The Table below indicates the Offices which were not consulted for the reasons below (i) and (ii). These are:

- SOEs and statutory bodies which were clearly established under their own laws, and thus their administrative status was uncontested.
- (ii) The Offices which confirmed they did administer the laws from the Commission's preliminary research findings.

## (d) The Consultation Questions

Consultation Questions differed across the Ministries/SOEs/Constitutional Offices. The individual consultations commenced, where the Commission consulted with the Ministries, SOEs and Constitutional Offices on their responses to the letter seeking their confirmation on the laws they administer. In addition and more importantly, discussions were on the outdated laws which the government offices were of the view were no longer applicable or useful in their respective line of work. The laws which were non-contentious were not discussed except where there was some need for confirmation. For example which Ministry/SOE/Constitutional Office was the 'principal' administrator and which were 'other' or 'partner' administrators, or offices which also played a role in implementation.

The Table below is a sample of the Queries/Consultation Questions sought of the Ministries, SOEs and Constitutional Offices at Consultations. The responses from these consultations significantly informed the findings in this Final Report. The Commission is grateful for the support of all Ministries, SOEs and Constitutional Offices consulted.

## (e) Analysis

At the end of each consultation, the Commission collated the responses in a record of confirmed laws administered by confirmed Ministries/SOEs/Constitutional Offices, in preparation for the development of the Final Report. Significantly, reasons for repeal of certain laws were confirmed as recommendation and instructions from the Ministries/SOEs/Constitutional Offices, so the Commission would be making recommendations in the Final Report informed by the recommendations and instructions from the Ministries/SOEs/Constitutional Offices.

The **research on each law** undertaken by the Commission also assisted the Ministries/SOEs/Constitutional Offices in their decisions whether to recommend to the Commission the repeal or review of their laws. This forms part of the crucial records under this Project, which would provide as authority and reference, responses to any question arising after the completion of this Project on the reasons certain laws are no longer part of the fabric of the laws of Samoa.

## **ANNEXURE 3** OFFICE OF THE REGULATOR START TO THE REVIEW OF THE LEGAL FRAMEWORK

#### START TO THE REVIEW OF THE LEGAL FRAMEWORK

#### Legal Framework:

- There is confusion and a lack of clarity as to where the existing policy plans should be listed;
- OOTR raised the issue that there is a duplication of provisions in the Acts that are irrelevant (i.e there are provisions in the Broadcasting Act similar to those in the Telecommunication Act that should not be in the latter because they are only relevant for Broadcasting related matters)
- As a solution, OOTR suggested that this may be solved by creating one framework with one overarching law that establishes the OOTR with clarifications of its multiple regulatory functions (which may be dealt with under separate laws)
- This will also clarify that there is one Regulator to oversee Broadcasting, Postal, Electricity and Telecommunication related matters rather than proposing multiple Regulators when in practice there is only one existing

#### Recruiting and training Staff:

OOTR acknowledges that it is vital to employ people with the capacity to work in the OOTR because of the need for expertise or specialisation.

There is a need to prevent high annual turnovers in terms of man power and to retain well qualified and experienced staff and this can be attained through alluring salaries which matches the amount and quality of work that eligible staff are doing.

Due to the nature of the work and sectors it regulates, (dealing with constantly changing technology), there is always a need to employ staff of a certain capacity and with required qualifications, a need to upskill existing staff to enable the performance of functions of the OOTR. With this, OOTR recommends some reform that will give OOTR independence from PSC selection and recruitment process. The current process of recruitment is problematic because OOTR feels that PSC do not fully understand the nature and needs of OOTR's work and OOTR would be in a better position to decide not only on the expertise needed but also in terms of its support staff. OOTR feels their hands a tied when it comes to trying to retain their staff whose capacity were built under the OOTR, unfortunately, their requests are often either addressed late or ignored.

## Conflict of Interest:

OOTR notes the issue of there being a conflict of interest where the Minister they are to report to is concerned:

- Under the Telecommunications Act 2005 and the Broadcasting Act 2010, OOTR is to report to the Minister of Communication, Information and Technology;
- For the Electricity Act 2010, the Regulator reports to the Minister of Works, Transport and Infrastructure and OOTR raises that this also raises an issue of conflict of interest.
  - OOTR regulates EPC (service provider) but they have to report to MWTI so when there are decisions that need to be made for service providers there is a restriction because of this Conflict of Interest
  - OOTR regulates 2AP which is under MCIT, but when it comes to reporting, the Regulator reports to MCIT

### Independence:

In light of the above, one of the main issues faced by OOTR is in relation to their independence. OOTR is of the opinion that given their role, they should be independent of the Government in terms of decision making rather than answering to and reporting to the Government to some extent. OOTR also states that the preferred structure would be one similar to that of CBS.

#### Decision making/legal assistance

One of the issues faced is in relation to renewal of carriers/service providers licences

- In the Act, it's the licensee's obligation to come and renew license but some of them do not do that.
- OOTR sends people letter to tell them the license is due and need to be renewed and in order for them to renew the license they need to pay the license fees.
- AG says that what OOTR is doing is wrong. There should be a contract. OOTR tells AG that from their interpretation the contract is the license because it has conditions.

#### - Restructure in the public sector:

- Another issue raised is the uncertainty of whether OOTR is a Ministry, SOE or Constitutional Body. Confirmation of this will assist in confirming the relevant and suitable structure and its day to day operations
- (i.e recruitment of staff, management of its budget, funding of positions, and managing its earned revenue)
