REVIEW OF THE FAMILY LAWS OF SAMOA

The Review of the Family Laws of Samoa was initiated in response to a recommendation from the Judiciary (during the Commission's consultations for its Review of the Fabric of Laws of Samoa in 2017) that the family laws of Samoa were in dire need for review and updating. After several preliminary discussions with the Ministry of Justice and Courts Administration (MJCA) as the administrator of the family laws, it was agreed that the Commission leads this Review. A Terms of Reference was developed by SLRC and consequently approved by the Office of the Attorney General in 2018. The six (6) family laws reviewed are as follows:

- 1. Infants Ordinance 1961;
- 2. Marriage Ordinance 1961;
- 3. Divorce and Matrimonial Causes Ordinance 1961;
- 4. Maintenance and Affiliation Act 1967;
- 5. Family Safety Act 2013; and
- 6. Family Court Act 2014

The Commission followed the six (6) stages law reform process for the Review of the Family Laws of Samoa. The following stipulates the progress of this Review for the period of this newsletter July - December 2022:

PROJECT UPDATES

1. Review of the Arms Ordinance 1960

This Review was requested by the Ministry of Police, Prisons and Correctional Services (MoPPCS) in 2019 stating that this law, as a pre-independence law requires updating to allow the MoPPCS to implement its duties and functions in line with current practices to suit the context of Samoa. A Terms of Reference (TOR) was developed following preliminary consultations between the Commission and the MoPPCS, and was later endorsed by the OAG in (Stage 1 - TOR).

The Commission commenced its preliminary research (Stage 2 - Preliminary Research and Consultations) on this Project in the FY 2020-2021. This was put on hold due competing work priorities needing urgent attention and assistance by the Commission.

In June 2022, the Commission re-commenced this Review and therefore re-commenced its preliminary research and consultations.

On 17 November 2022, the Commission carried out a refresher meeting with the MoPPCS as the administrator of this Ordinance to confirm any further issues (within the scope of the TOR) to be considered in this review whilst the Review is still at its early stages. The Commission continues to liaise with the Ministry for the relevant information to guide and inform the Commission's preliminary research and consultations.

The next issue will report on the progress of this review.

2. Review of the Traffic Laws of Samoa

In 2019, there was a notable increase in the number of traffic related incidents in Samoa. A preliminary legislative review by the Commission submitted to the Former Honorable Prime Minister highlighted the need for a full review of Samoa's traffic laws.

Upon the Commission's proposal, the Former Honorable Prime Minister approved a Terms of Reference on 29 July 2019 for the Commission to conduct a full review of the Traffic Laws of Samoa.

The Traffic Law Review focuses on the following laws:

- Road Traffic Ordinance 1960 (including Regulations, Orders, Rules);
- Road Traffic (payment of Fines) Act 2009 (including Regulations, Orders, Rules); and
- Road Transport Reform Act 2008 (including Regulations, Orders, Rules).

The Commission is currently finalizing the Discussion Paper and is anticipated to submit to Cabinet for their approval in January 2023.

Public and stakeholders' consultations are anticipated on the second half of this financial year 2022 - 2023.

COMMENTS/FEEDBACK BY THE COMMISSION

From July to December 2022, the Commission provided comments and feedback in relation to 3 (three) requests from other Government Ministries. These type of requests usually require that the Commission researches and formulates its own views and feedback on a legal query or issue.

The Commission has endeavored to respond speedily and effectively following its legal research and analysis. The following Table attempts to highlight the nature of requests received, upon which legal reviews were undertaken and responses made.
